### To whom it may concern,

As a Bishop resident, I write in support of the reduction in groundwater pumping proposed by Inyo County this year. As I am sure you are aware, our valley receives little precipitation, on average just over 5 inches per year, and relies on snowmelt streams from the surrounding mountains as its primary water source. This year's severe drought has left only 5% of the normal snowpack on the mountains. We face a perilously dry summer. As Topanga Canyon burns so early in the season, I'm sure that you can empathize with our fear of fire. On my walks each morning, I pass the burn scar of a fire that nearly reached my neighborhood a few years ago. I listen to the sound of your nearby water pump and wonder how much lower the water table is now and how much more quickly the vegetation will burn the next time it catches fire.

The risk of fire makes a temporary reduction in pumping urgent. A long-term reduction is vital for the health of the valley. A hundred years ago, you drew from a valley still lush and green from centuries of irrigation by the local Paiute people. Their ditches slowed the water's flow and spread it across the valley floor, raising the water table and building habitat for plants and animals alike. It has been a long time since they have had the opportunity to carry out this practice, and your wells have drained much of the available groundwater. The resulting vegetation loss has been well-documented. Many of us here rely on wells and fear that they will soon run dry. The water table must be allowed the opportunity to recover.

Lastly, I would like to urge that the Standing Committee membership be revised to include permanent Tribal representation. Given the Paiute and Shoshone's long history of water management and the oversized impact of water availability on their community well-being and sovereignty, they should be consulted on all questions of water allocation.


